

TARRANT COUNTY PUBLIC HEALTH (TCPH) COVID-19 VACCINATION PROGRAM

In the section below, you will find tables and graphs to illustrate Tarrant County vaccination trends; however, please note that some of the data below displays doses *directly* administered by TCPH and does not reflect the total number of vaccinations administered by contractual and clinical partners. 


Figure 2. First dose, second dose, and third dose COVID-19 vaccination trends as reported by Tarrant County Public Health (TCPH) over the preceding three-month period. Most recent data may not be complete due to a lag in reporting.




Figure 3. First dose, second dose, and third dose COVID-19 vaccination trends since the inception of the COVID-19 vaccination program. Most recent data may not be complete due to a lag in reporting.
