Dear Sir:

You will notice that there has been some changes made in Form H this year, 1908-9. Examine this form well before beginning to make your report.

Your attention is called to the fact that Section 50 of the school laws, edition of 1907, requires that the different classes of school funds be kept under separate accounts. Form H is made so as to comply with this law, requiring a separate report on the different classes of funds. First, the receipts and disbursements of State and County Fund are called for in summary and in detail. Second, receipts and disbursements of the Local Maintenance Fund are called for in summary and in detail. Third, the Land Account is called for.

Unless the balances brought forward in State and County Funds and in Local Maintenance Fund are the same as the balances in these funds as shown in previous year's report, your report can not be approved.

The balances on August 31, 1909, must be such amounts as will properly close up the accounts. The balance in any fund is always the difference between the receipts and the disbursements in that fund.

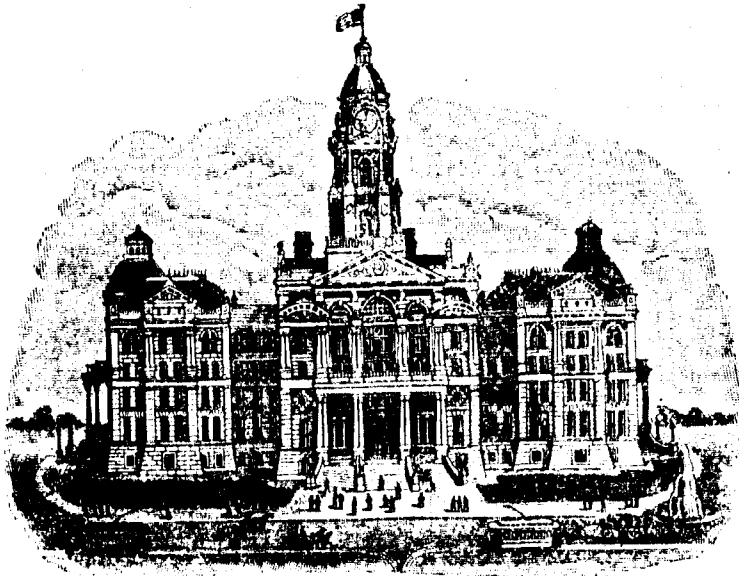
The Land Account must be given in full before your report can be approved.

Do not fail to make the report called for on pages 23 and 24, if you paid out any of the State and County Fund for incidentals, etc.

If you are not county treasurer on August 31st, 1909, hand this letter and the two copies of Form H to the person who is county treasurer on that date. In making your report if you need any extra sheets order them from the department.
