Re: Auditor's Report – Controls Over the County's Fleet Fuel Cards

SUMMARY

In accordance with the Local Government Code, we reviewed the controls over the County's fleet fuel cards for the fiscal year ended September 30, 2017. The objective of our review was to determine whether fleet fuel cards were adequately controlled and vendor invoices were accurate. During our review, we observed that overall controls in place were adequate and that invoices were materially accurate. Additionally, we observed less significant items that were communicated to the Purchasing Department related to certain activities not specifically addressed by current policies.

BACKGROUND

Since December 2015, Tarrant County has contracted with FleetCor to provide fleet card and fuel management services. As of September 30, 2017, there were 240 fuel cards issued to County departments. Tarrant County paid approximately \$693,575 to the vendor for the fiscal year ended September 30, 2017.
