RE: Auditor's Report – Review of Certain Ad Valorem Refunds

SUMMARY

In accordance with Local Government Code Chapter 115 and Texas Property Tax Code Section 31.11, we performed a review of ad valorem refunds issued to taxpayers for the six months ended December 31, 2017, that were *not* approved by the Auditor's Office prior to payment. The objective of the review was to determine whether refunds were valid and paid to the correct taxpayer for the correct amount. We selected 100 refunds that were *not* approved by the Auditor's Office prior to payment and found that they were valid, accurate, and properly approved. However, we observed that the vendor had not adequately addressed certain system functionality requirements in *RefundTrac* that were previously reported. The vendor implemented the functionality after the audit but prior to the issuance of this report. No further recommendations are necessary.

Additionally, we observed system security for *RefundTrac* was not adequate. While the vendor made some changes prior to issuance of this report, we believe significant risks still exist. As a result, we made additional recommendations to Tax Office management. We will continue to monitor these items and collaborate with the Tax Office and the Information Technology Department.

BACKGROUND

The Texas Property Tax Code governs the process of refunds, including both the role of the auditor and tax assessor-collector. Section 31.11 of the Texas Property Tax Code defines the responsibility of the Auditor's Office. In July 2017, the Auditor's Office proposed revising the dollar limits of refunds submitted to our office for review and approval prior to payment. The revised guidelines are in accordance with statutes for a county with a population of two million or more. The Tax Office agreed with the revised guidelines.

The Tax Office issued 20,705 refunds totaling \$20 million for the period July 1, 2017 through December 31, 2017. During our on-going statutory review, 116 refunds totaling \$1,981,156 were presented to the Auditor's Office for review and approval. Two refunds totaling \$128,247 were rejected for varying reasons and resubmitted by the Tax Office.
