## **COMMISSIONERS COURT ACTION REQUESTED:**

It is requested that the Commissioners Court receive and file the Auditor's Report of the Cash Counts of the Tarrant County Tax Offices.

## **BACKGROUND:**

In accordance with Local Government Code, the Auditor's Office conducted surprise cash counts at seven (7) of the eight (8) Tarrant County Tax Office locations from March 22, 2021 through March 26, 2021. The Poly Subcourthouse location was counted and results were reported on March 8, 2021. The objective of the review was to determine whether cash and other remittances reconciled at the time of the count and safeguards were in place to protect County assets.

In accordance with Local Government Code, the Auditor's Office conducted surprise cash counts at seven of the eight Tarrant County Tax Office locations from March 22 – March 26, 2021. The Poly Subcourthouse location was counted and results reported March 8, 2021.

The objectives of our review were to determine whether:

- Change funds and remittances were accurately recorded and properly reconciled to the respective accounts;
- Change funds were used only to make change in connection with collections payable to the County and were not used to make loans, advances, or to cash checks or warrants of any kind; and
- Physical safeguards were in place to protect County funds.

Of the seven locations counted, two locations had immaterial differences that will be recorded to their Over / (Short) general ledger accounts.
