


4TH ANNUAL HEALTHY LIVES MATTER ALZHEIMER'S EDUCATION SEMINAR

The 4th Annual Healthy Lives Matter Alzheimer's Education Seminar was held on Saturday, August 17, 2019 at Tarrant County College Trinity River Campus. Over 300 participants, healthcare professionals and volunteers were in attendance with 37 vendors providing dementia support services and other essential resources.

Sessions included a focus on sibling relationships, mental health and the aging population, the future of prevention, cost of care, brain health in women, and enhancing care through communication and activity. Dementia Live, a high-impact dementia simulation experience immersed participants into life with dementia, resulting in a deeper understanding of what it's like to live with cognitive impairment and sensory change. Commissioner Brooks shared his own personal story as a caregiver and how this devastating disease not only impacts a family or a community, but an entire nation.

BE SURE YOU BRING:

- Photo ID
- Original Social Security card or ITIN for each person listed on the tax return
- Copy of last year's tax return
- All W-2 wage statements for 2018
- 1099 SSA, 1099-R and 1099-G
- Cash income amount and work expenses
- 1095 Health coverage form
- Direct deposit information

Tax preparation assistance available for tax years 2016, 2017 and 2018.

*Amendments of returns are only prepared at VITA tax centers.














TARRANT COUNTY 17P PREMATURITY PREVENTION PROGRAM

WHAT IS PRETERM BIRTH?

Preterm birth is a birth that takes place more than three weeks before the baby's estimated due date. In other words, it is a birth that occurs before the start of the 37th week of pregnancy. Premature babies often are at an increased risk for medical problems.



Risk factors:

- 1. The greatest risk for giving birth to a baby too soon is if you have already had a baby that was premature
- 2. African American babies are at a high risk of being born early although preterm birth affects babies of all races and ethnicities

The 17P Program

17P is an injection of progesterone (a naturally occurring hormone) medication that can help delay having your baby too soon.

You may be eligible for the 17P medication if:

- 1. You have been diagnosed with a history of a singleton premature birth for non-medical reasons between 20 and 36 weeks gestation, AND
- 2. You are currently pregnant with one baby

If this criteria applies to you, contact us!

Program participants will be contacted by phone every 2 weeks until delivery. If participants receive progesterone therapy (17P), they will receive a \$25 gift card after they give birth.

Who Qualifies

If you have children 14 years and younger, live in Tarrant County and meet Income Guidelines, you may qualify to receive gifts for your children during the holiday season.

What to Bring

Photo ID of applicant - must be age 18 and older.

Proof of ALL INCOME for EVERYONE in the household (benefit letters/pay stubs/income tax/ TANF document, etc.) for the past 30 days is required.

Proof of Tarrant County residence.

Provide Household expenses (rent/mortgage/water/ light/gas, etc.)

Proof of age for children 14 and younger (birth certificates, shot records, etc.)

We cannot process you without these documents.


