#### Precinct 3 Maintenance Center News December 2021



This past year has been a very busy year for our construction and maintenance crews. In Fiscal Year (FY) 2021 (October 2020 - September 2021), we completed 47 Interlocal projects (Rehabilitation and /or resurfacing) in 10 different cities (Bedford, Colleyville, Euless, Fort Worth, Haslet, Hurst, Keller, Richland Hills, Southlake, and Westlake). One highlighted project includes new road construction that extends John Day Road to connect Avondale Haslet Road and Blue Mound Road in Haslet. All projects were completed on schedule and within the estimated budgets. Our partnerships with the cities this past year yielded an estimated savings of \$3.70 million dollars to the cities in saved construction cost.

Additionally, we completed roadway projects (rehabilitation and/or resurfacing) on three county roadways within unincorporated Precinct 3, including the

widening and addition of turn lanes at the intersection of Bonds Ranch Road and Wagley Robertson Road. We also made roadway improvements and/or provided the needed maintenance within several historical cemeteries. Other County roadways received localized base repairs, crack seal and spot seals as preventative maintenance measures to protect and extend the life of the existing pavement. Overall, we closed out the fiscal year achieving all our planned objectives - another successful year.

Work is already well underway in FY 2022. Since October, we have completed eight rehabilitation projects in Watauga, one rehabilitation project in North Richland Hills, and four rehabilitation projects in Fort Worth, and we have just started the rehabilitation of Oak Grove Park Road in Grapevine. Currently, we are finishing up our last mowing cycle for the year, trimming back trees in the right of ways, cleaning ditches and culverts, and making localized roadway repairs on the County roadways.

FY 2022 is shaping up to be another very busy year with 73 requested Interlocal Roadway Projects so far. We are currently estimating the cost, preparing agreements and scheduling construction located throughout 13 Cities within Precinct 3 for construction in FY 2022. Overall our county roadways are in good condition, and we only have routine preventative


maintenance planned for the next year.

Quality workmanship, timely construction, good stewardship, citizen response, and partnering with our cities are some of the areas we strive to excel in serving the public. However, no value is more important to us than safety – both of our employees and the traveling public. We continuously discuss, train, and emphasize safety on every project, every day, and in everything we do. On October 29th, we held our annual Truck "Roadeo." For this event our equipment operators practice maneuvering dump trucks through several obstacle courses that mimic driving and construction situations to further develop and improve their driving, backing, and communication skills. The event concluded with a competition for top driver, awards, and lunch.

As always, your safety and the safety of our crews are of the utmost importance. When encountering any type of roadway construction or maintenance, please be patient, drive slowly through the construction area, and be keenly aware of the equipment and personnel working around you to make your commute safer long after they are complete.


