## **COMMISSIONER'S CORNER**

Wow, this year is really flying by fast! Since our February Newsletter, we have completed our Fourth Annual Northeast Tarrant Transportation Summit. We had over 550 attendees. Our Seminars included an overview of the TEX-Rail/ Cotton Belt Rail Line by Fort Worth Councilman Jungus Jordan; How Transit-Oriented Development can transform the Marketplace by Paris Rutherford; The ABC's of the RTC (Regional Transportation Council) by Michael Morris, NCTCOG; Up-dates on the DFW Connector and the North Tarrant Express projects and our key-note speaker was Ross Perot, Jr. A special thanks to all of our sponsors (see page 6 for listing), chambers, cities, and volunteers who helped make this the best Summit we have presented.

If you haven't noticed, we are moving from the Sub-Courthouse in Hurst on Grapevine Highway to the Southlake Town Hall facility located at Southlake Town Square as well as a location in Bedford. By Monday, April 15, everyone will be out of the building and re-located to a temporary location. The Commissioner, Constable, and Justice of the Peace Court have all moved their offices to the Southlake Town Hall located at 1400 Main St., in Southlake. The Tax Assessor/Collector, County Clerk, and Credit Union will be temporarily located at Parkwood Village, 201 E. Harwood Rd., in Bedford; and Juvenile Services is located at 3809 Colleyville Blvd., #D in Colleyville. In mid-July we will have a ground breaking for the construction of the new Northeast Tarrant County Courthouse. The floor plans and site plan

are available for viewing in our Southlake office, at the Parkwood Village location in Bedford, and in our February issue (page 4) of the Northeast Newsletter. As construction progresses, we will keep you up-to-date with reports and photos.

The LifeGift Second Chance Run will be held on May 18th at 1701 River Run, Fort Worth (same location for the last few years) which is near University Dr. and the Trinity River. This is a 1 Mile Fun Run/ Walk and a 5K Run/Walk. This LifeGift Run is an opportunity for people to be made aware of organ donations and the transplant process. Five years ago, I received a lifesaving liver transplant. Today, there are over 117,000 individuals on a waiting list for an organ transplant. Public awareness is the key to providing vital organs to those who need these life saving procedures. This will be our 4th year to participate as **Team** Fickes. Please come and join with us! (Registration form can be found on page 5)

Coffee with the Commissioner will be next **Friday, April 19th** from 7:30 to 9:00 at the **Southlake Town Hall.** This will be our first coffee in the Town Hall and will be the location for our coffees for the next 18-20 months. The Southlake Town Hall is located at 1400 Main Street, Southlake TX 76092 and we are located in Suite 410. We hope you can join us!

#### Meet Mayor Betsy Price

Betsy Price, a Fort Worth native, was elected as the 44<sup>th</sup> Mayor of the City of Fort Worth June 18, 2011.

Prior to taking the reigns as the Mayor of the 16<sup>th</sup> largest city in the United States, Price served as the Tarrant County Tax Assessor. There, she transformed the Assessor's Office into one of the most efficient in the State of Texas, saving

taxpayers millions. Before her life in the public sector, Price was owner of a successful title company called Price Cornelius Title.

Since taking office as Mayor, Price has initiated a broad agenda founded on the values of fiscal responsibility, accessibility, accountability and customer service. More specifically, Price continues to work with her City Council colleagues, city staff and local partners on several local initiatives, including engaging young leaders; promoting a healthy, active city; creating and retaining jobs; expanding public transit; and engaging faith communities.

Mayor Price graduated from Arlington Heights High School and earned a bachelor's degree from the University of Texas at Arlington. Since then, she has been a leader in the Fort Worth community serving on numerous boards, commissions and professional associations. Her roles as businesswoman and community activist has garnered her the reputation as an innovator with strong leadership in solving

some of the most pressing issues in one of Texas' fastest-growing cities.

She has been married to Tom, an insurance agent, for more than 40 years and has three children: Kathryn, Phillip and Paul. Price is also a proud grandmother to her grandsons Chappell and Price.

### TARRANT COUNTY COMMUNITY SUPERVISION AND CORRECTIONS DEPARTMENT

The Community Supervision and Corrections Department of Tarrant County (CSCD) was known as the Adult Probation Department until 1989. At that time the Texas Legislature instituted the name change, owing in part to the greatly expanded role of probation in the state's criminal justice system. With wide-ranging advances in offender assessment, supervision, and technology, came the realization that many non-violent criminal offenders could be effectively monitored in the community. This saving taxpayers millions of dollars by avoiding expensive prison confinement (\$50.04 per day in prison, \$3.00 per day on community supervision).

Currently, CSCD under the oversight

of the criminal courts of Tarrant County, supervises over 21,000 offenders in the community, most of whom are on "regular" supervision, meaning a set schedule of contact between the offender and a Supervision Officer, and the mandate that the offender abide by a specific set of rules (Conditions of Community Supervision) given to him or her by the judge. Supervision Officers (S.O.'s) are specially trained professionals whose dual roles consist of: assessing and monitoring the offender's behavior and reporting violations to the court, while at the same time offering the offender opportunities and resources for behavioral change, in an effort to avoid future criminal activity.

In addition to regular community supervision, CSCD also operates special programs for specific offender groups such as: high risk DWI, mental health/ developmental disability, sex offenses, veterans, prostitution, drug/alcohol addictions, pretrial bond defendants. Programming for these selected groups is generally much more intensive than regular supervision and there is a higher rate of contact between the S.O. and the offender.

CSCD also provides a financial benefit

to the public in having approximately 40% of its funding provided by offender fees, in restitution per year from offenders greatly reducing reliance on tax dollars. CSCD also collects over \$2,000,000 per year from offenders in restitution which is sent to victims of crime in Tarrant County. Finally, offenders under CSCD's supervision perform over 500,000 hours annually in unpaid Community Service Restitution for nonprofit and charitable groups, valued at more than \$3,770,000.

Five years ago, Tarrant County Commissioner Gary Fickes underwent a liver transplant due to complications from a disease he found out he had five years prior. Being an organ recipient himself, Commissioner Fickes has great appreciation for those who are organ donors and deems them and their families as heroes.

According to the U.S. Department of Health & Human Services, 117,276 people are currently waiting for an organ, 18 people will die each day waiting for an organ and 1 organ donor can save up to 8 lives.

Commissioner Fickes was able to have a new lease on life after he received the vital organ needed for his survival from the difficult decision of one's family. The LifeGift 2nd Chance 5K & 1 Mile Fun Run/Walk helps bring awareness and raise money for LifeGift, a not-for-profit organ procurement organization that recovers organs and tissue for individuals needing transplants in 109 Texas counties.

#### Question of the Month

Question: Who was General William Jenkins Worth?

Answer: General William Jenkins Worth, for whom the city of Fort Worth was named, is buried beneath a monument on the corner of Fifth Avenue and Broadway in New York City. Worth, a New York native, served in the war of 1812. Although not a graduate of the academy, he served as commandant of West Point Military Academy from 1820 to 1828. He served in the Mexican War under both Zachary Taylor and Winfield Scott and was brevetted as a brigadier general for service in the Seminole War. Worth was ordered to Texas in 1848 and died there in 1849. He was returned to his native state for burial. The military establishment, Fort Worth, and the city which grew from it, were named for him.

## **Community Enrichment Center**

Restoring Hope, Sharing God's Love, and Changing Lives for 25 Years

The Community Enrichment Center (CEC) is a vital resource in Tarrant County, providing a myriad of services to homeless families, women and children fleeing domestic violence, seniors and low-income families.

The CEC's mission: restore hope, share God's love and change lives in our community. What began in 1988 as a food pantry, has grown into a multi-service organization including four major programs:

Last year, Open Arms (transitional housing for victims of family violence) provided safe and stable housing to 53 women and 119 children fleeing violence, and staff responded to 3,796 crisis calls. Open Arms' goals are to help victims heal,



break the cycle of violence and transition to a healthy life without violence.

Adopt-A-Family (transitional housing for homeless families) housed 131 homeless adults and 233 children in 2012. Case managers assist families to break barriers



keeping them from success. They receive life skills training including financial literacy (budget), parenting skills, counseling and help improving their education level and income potential.

The Community Ministries (Food Pantry, Senior Network) distributed 900,000 pounds of food in 2012. Approximately 60 seniors participate weekly in the Senior

Network where they are able to prevent isolation by taking part in fun activities, devotionals and service projects.



The CEC's Education & Employment Services works with unemployed and low income working families to improve their earning power. Staff works one-on-one with participants to create resumes, search for jobs, provide career assessments and prepare for interviews. Literacy for Life improves literacy skills and prepares adults for the GED test.

In 2013, the CEC is celebrating 25 years of providing services that truly change the lives of individuals and families. Thank you volunteers and partners for helping to ensure the CEC will continue to serve those in our community who need us the most.

### An Historic Moment in Time Southlake Historical Society



You may know your Texas history, but you may not recall that in 1846 (three years before a lone outpost, Fort Worth, was established on the banks of the Trinity) farming families were settling the northern edge of Tarrant County (and most of Denton County). They were Peters colonists -- men and women who contracted with Texas for free land as part of the republic's efforts to populate the rugged frontier. Southlake is a part of this history.

The Southlake Historical Society's mission is to promote the preservation, understanding and appreciation of our community's history. Like other historical societies, we research and document area history, including oral histories, and present programs with knowledgeable speakers.

But our most recent and important way to accomplish the society's mission through our website, www.southlakehistory.org

which we have just revamped to establish a virtual historical society that includes an interactive map of historical places; quick facts including how Southlake got its name; the stories of Lonesome Dove Baptist Church, Lake Grapevine and D/FW airport; and much more.

Also on the site are hundreds of photographs and several videos that offer the experience of a guided tour. An important feature is "Tell Us Your Story," where people are encouraged to submit their own — or their family's — stories and recollections of Southlake.



Our website recently was nominated for an American Association of State and Local History award. Tarrant County archivist Dawn Youngblood did one of the "critical reviews" necessary for the nomination, and we appreciate her critique and insights. We also appreciate Tarrant County Commissioner Gary Fickes, who organized the society back in 1992 by placing a notice in the newspaper asking people interested in Southlake history to meet.



When you visit the website, you'll find many historical places to explore in South-lake. Stop by the log house, north of the intersection of White Chapel and South-lake Boulevard and read the colorful "Home Sweat Home" signs prepared by the SHS. Kids will enjoy Bonnet the blue dog, who gets them thinking.

On Carroll Avenue just north of Texas 114, visit the 1919 Carroll School (next to the lacrosse field, which was the first Dragon football field). It's the only remaining intact school in Tarrant County from Common School District days. A historical marker we researched and wrote is next to Carroll Avenue. Nine more historical markers can be found around town – learn where they are on our website.

Watch our website's home page for upcoming programs and events. And get to know your north Tarrant County history a little better.

• In mid-February, crews moved SH 114 from William D. Tate Avenue to Texan Trail to the north onto new concrete enabling them to rebuild the eastbound SH 114 mainlanes. The southbound SH 121 exit from westbound SH 114 is now a right exit, and the eastbound SH 114 off-ramp to Main Street is now combined with the off-ramp to SH 26/William D. Tate Avenue.

- In the upcoming months, maintenance of traffic crews will perform permanent striping work on westbound SH 114 from Freeport Parkway to International Parkway, northbound International Parkway north of DFW Airport and the FM 1709/Southlake Boulevard bridge at SH 114. Crews will also focus on paving east and westbound SH 114 from Texan Trail to Freeport Parkway, eastbound SH 114 from Texan Trail to International Parkway and the north intersection at Texan Trail.
- Finally, our structures crews reached major milestones recently by setting the last girders (horizontal bridge beams) and pouring the last bent cap on the DFW Connector project! (Pictured: Crews recently paved the westbound SH 114 mainlanes from Main Street to William D. Tate Avenue.)

• Traffic is now on the permanent north and southbound lanes. Two lanes of traffic are being maintained in each direction while work continues. Additional upcoming construction items include the installation of decora-

Additional upcoming construction items include the installation of decorative medians, sidewalks and the planting of trees and shrubs. Completion is estimated for this summer.

• SH 26 - Colleyville: The \$11.4 million project from Brumlow Avenue/Pool Road to John McCain Road in Colleyville continues. The project is widening the road to three lanes in each direction with raised curb medians and left turn bays. As part of this project, the bridge over Big Bear Creek will also be reconstructed. Construction continues on the northbound lanes and includes drainage improvements and the installation of box culverts through spring of 2013. Two lanes of traffic will be maintained during peak driving times. Motorists will be shifted to the northbound lanes later this year. The project is estimated for completion in 2014.


