Vinny Taneja has served as Health Director for Tarrant County Public Health since September 2014. He brings to the department 13 years of experience in public health and healthcare at the local, regional and state levels.

Most recently, Taneja served as the Deputy Health Officer for a large urban county health department in Michigan.

He received a medical degree (MBBS)

from Manipal Academy in India. He then pursued his passion for public health by obtaining a Masters in Public Health (MPH) at Eastern Kentucky University in Richmond, Kentucky.

In 2006, Taneja served as an ambassador to the Wisconsin Governor's e-Health Initiative. He helped develop a strategic plan for statewide adoption and exchange of electronic health records. He also served as the Chair Alternate for Wayne County Executive, on the Wayne County 4 Star Board and also on the boards of Voices of Detroit Initiative (VODI) and Child's Hope.

Taneja graduated as a fellow from Mid-America Regional Public Health Leadership Institute (MARPHLI) at UIC Chicago. His focus was on Public Health Leadership under the Affordable Care Act. He is passionate about Health Disparities and addressing the Social Determinants of Health.

We are very thankful for the many businesses that have chosen Hurst and the HEB area to operate their business in. There are over 1300 businesses in Hurst and they were recently recognized at the Hurst Business Appreciation Dinner. Outstanding achievement was celebrated

with three Outstanding Business Awards. The winners were Bacon's Bistro & Cafe, Animal America Pet Resort and Rebounderz Trampoline Arena. There is a lot to highlight in 2014 including the recent completion of the 121/183/820 Highway expansion which offers 40% more vehicle capacity and represented an early Christmas present with its completion nine months early. Surprisingly, Hurst has maintained positive retail sales growth throughout the construction with the most recent month being as high as +11%!

Brisk retail real estate activity continued through the 3rd quarter as 33 new businesses occupying 120,000 sq. ft. opened in the quarter. 107 new businesses have opened year-to-date. The new openings were highlighted by the introduction of the new Sprouts grocery store on Hwy 26 and Freedom Sports who opened their new motorcycle, four wheeler and waverunner 30,000 sq. ft. showroom. You won't go hungry in Hurst as nine new restaurants have opened this year including Las Daisy's Mexican Restaurant and Quick Thai Bistro this quarter.



New Walmart Neighborhood Market to soon start construction in south Hurst

The City of Hurst continues its focus on the Pipeline corridor and has enjoyed the opening of five new restaurants on Pipeline in the last year. The project that may have the greatest impact on the revitalization of this important corridor was just recently announced; "The Shops at Hurst". This new 90,000 sq. ft. shopping center will include the total transformation of the 10 acres on the NE quadrant of Pipeline and Precinct. Existing buildings will be demolished and four new buildings will be built with a highly requested Walmart Neighborhood Market grocery store as the anchor. Construction will start soon with an opening planned for late 2015. 



Emphasis is placed on practicing safe backing techniques, communication between drivers and spotters, and maneuvering a truck through tight areas.

The Arc of Northeast Tarrant County



The Arc of Northeast Tarrant County is a small 501(c) (3) membership non-profit organization whose mission is to improve the quality of life for people with intellectual and related developmental disabilities. It was formed in 1971 by a group of parents who joined forces to fight for their children's rights to be educated in the public school system.

The Arc of NETC is an all volunteer-run agency. All board members are family

members of or individuals who live life with a disability label. Most of our volunteers have children who have a disability themselves. The Arc of today still serves as a voice in the local, state and national community.

The Arc of NETC is an affiliated chapter of The Arc of the US and The Arc of Texas is held to a common set of core values and positions related to quality of life, inclusion, rights, etc. These position statements have been adopted by The Arc's general membership.

The Arc of NETC promotes the human rights of individuals who have intellectual and developmental disabilities and actively supports their full inclusion and participation in the community throughout their life span. We serve the community with outreach, information and referral, educational workshops and social activities.



Our vision for the future is a world where people with disabilities are included in their communities and where quality supports and services respond to their needs and personal choices.

We do not really have set hours of operation since we answer phone calls and emails at various times. People do not typically visit our location at 1806 Haltom Road unless we have a scheduled workshop or social activity.

AN HISTORICAL MOMENT IN TIME

Jellico, Texas

Jellico Texas was located near the intersection of Farm Roads 1709 and 1938, in the area of present-day Southlake in northeast Tarrant County. Robert Emmett Wilson, founder of the settlement, purchased property in the W. R. Eaves Survey north of Big Bear Creek in Tarrant County in 1881. In 1888, he purchased an adjoining property in the J. G. Allen

Survey and built a general store on the north side of the Keller-Grapevine Road.


The town was named after the Jellico Ranch, on which the general store was located; early settlers in the area had originated in Jellico, Tennessee.

The Jellico Post Office was established in 1898 and served 300 people. Wilson purchased a steam-operated cotton gin in 1895 for \$7,000 and moved it south of the general store. A blacksmith shop, a gristmill, and a syrup press were also located adjacent to the gin. North of the general store, Lone Elm School operated from 1877 to 1917.

In 1907, the price of cotton and cattle dropped, and Wilson, as co-signer on a number of outstanding debts, sold the gin, mill, and cattle press. He then opened a dipping vat for cattle. With the advent of the automobile, shopping became easier in

the nearby communities of Keller, Grapevine, Smithfield, and Bransford, and the Jellico general store ceased to be profitable. It was closed in 1912. The post office was discontinued in 1903. The only reminder of Jellico today is a shopping center called Jellico Square, built in 1984 and a street named Jellico Circle.



GRAPEVINE - PARKS

The City of Grapevine proudly operates and manages 38 park sites totaling 1,553 acres, a fully accessible playground, a lush Botanical Garden, an award-winning campground, a 27-hole championship golf course and a 26+ mile trail network renowned in the state and known for excellent hiking and mountain biking.

The Vineyards Campground & Cabins on Grapevine Lake has been voted one of the top 10 in the nation. It includes 10 courtesy boat docks, 13 RV sites, 14 fully furnished cabins, water, sewer and electrical services to all sites, a restroom/laundry room and a group pavilion.

Our Lake Park amenities include 10 boat ramps, 89 picnic sites, three large rental picnic pavilions, several restroom facilities and three playgrounds.

Athletic amenities include 10 tennis courts, 18 outdoor basketball courts, two outdoor swimming pools, 14 competition baseball/softball fields, 11 competition soccer fields and a disc golf course.

Our 27-hole championship golf course was voted the best course in Texas with a green fee under \$40 by *Dallas Morning News*.

Dove Park is our newest updated feature in Grapevine. This area encompasses Dove Waterpark (where nearly 2,000 people learn to swim each summer), Dove Sprayground and Casey's Clubhouse. This fully accessible playground is designed for children with limitations, those without limitations, children in wheelchairs and those who are not in wheelchairs. This one-of-a-kind custom park is exclusive to the State of Texas. Children enjoy a zip line, clubhouse, treehouse, 14' tube slide, an elevator, stimuli equipment for those with cochlear implants, a rumble slide (stimulating different back muscles), interactive water feature dolphins, stump jumper logs for climbing and a covered pavilion for picnics and birthday parties.



Midtown Express

- The 26-mile Midtown Express Project, formerly known as the SH 183 Managed Lanes Project, will increase capacity with the addition of TEXpress (managed toll) Lanes as well as reconstruct portions of main lanes and frontage roads on SH 183 (from SH 121 to I-35E), SH 114 (from SH 183 to International Pkwy.) and Loop 12 (from SH 183 to I-35E). Construction of the interim improvements will begin in early 2015 and is anticipated to reach completion in 2018.

- I-35W: Construction is now underway on the southern portion of I-35W, with the first bridge demolition at NE 28th Street taking place in early December. On the northern segment, work will begin on the reconstruction of Western Center Blvd. in early January. Motorists are encouraged to check

the website frequently for updated information on construction activity and closures, and sign up for e-alerts that communicate major incidents and upcoming closures and detours.

- The work on the SH 26 project in Colleyville from Brumlow Avenue/Pool Road to John McCain Road includes the reconstruction of the southbound lanes, retaining wall work, installation of concrete paving and improvements to

the John McCain Road intersection.

- As part of this project, Big Bear Creek bridge reconstruction includes the demolition of the northern half of the old bridge, the installation of retaining walls and the drilling of column shafts. The northbound section of the new Big Bear Creek bridge is now partially open to traffic.
- Two lanes of traffic will be maintained during peak driving times. Substantial completion is estimated in Spring 2015. The \$11.4 million project is widening the road to three lanes in each direction with raised curb medians and left turn bays.



- The intersection improvements at FM 1938 and FM 1709 are slated to begin early next year. TxDOT crews will construct dual-left turn lanes at all four intersections in order to address traffic backups on east and west FM 1709. This intersection construction is the first part of the

FM 1938 Phase II expansion that will connect the Phase I portion in Westlake to the upcoming roadway expansion along Randol Mill Avenue.
