Message to Tarrant County Precinct Four

As we welcome the cooler fall weather and the approaching holiday season, it's a great time to share the incredible progress happening right here in Northwest Tarrant County.

Recently, our office hosted a special public meeting alongside our partners from the City of Fort Worth, TxDOT, and the North Central Texas Council of Governments to share updates on the Bonds Ranch Corridor Project. This important initiative spans from FM 1220 (Boat Club Rd.) to Highway 287 and includes widening Bonds Ranch Road, adding new traffic signals to improve safety, and eliminating all rail crossings through two planned grade separations. This collaboration and rapid progress illustrate the power of partnership among local and regional agencies. We are proud to be delivering on our promise to build roads and infrastructure before thousands of new rooftops come to this area.

We're also making incredible progress on the \$16 million design for the reconstruction and widening of Boat Club Road. Our team is full steam ahead on engineering the needed improvements and right-of-way requirements to ensure the roadway meets our community's growing needs. We look forward to sharing updates in an upcoming public meeting and hearing your valuable feedback.

Finally, I'd like to invite you to join us for our annual Precinct 4 Fish Fry on Thursday, October 30th! Enjoy great food and fellowship—all for an incredible cause benefiting the Veterans of Tarrant County. More details can be found in the flyer later in this newsletter.

It remains my honor to serve as your County Commissioner. Bonds Ranch Road - Corridor









As mentioned by the Commissioner, on October 6th, Tarrant County, along with our partners: City of Fort Worth, North Central Texas Council of Government, and Texas Department of Transportation, hosted a public meeting about the Bonds Ranch Road Corridor Project. The six-part plan will aim to ease traffic congestion and improve safety. Over 150 residents learned plans about the project that will widen the road from two lanes to four lanes between Boat Club Road and U.S. 287 while eliminating all at-grade rail crossings.

Segment 1: Expands Bonds Ranch Road from two lanes to four, adding a raised median, new traffic signals, lighting, and continuous sidewalks for improved safety and capacity.

Segment 2: Constructs a grade separation over two active rail lines to improve mobility and eliminate traffic delays caused by train crossings.

Segment 3: Widens the roadway from two lanes to four, including a raised median, new signalization, lighting, and pedestrian sidewalks for safer access and flow.

Segment 4: Continues the widening project and opens the Wagley Robertson intersection to northbound traffic, improving connectivity and access for residents and commuters.

Segment 5: Builds a grade-separated crossing to eliminate an at-grade rail crossing, enhancing safety and travel reliability.

Segment 6: Implements breakout improvements tied to the broader Highway 287 project, adding new entry and exit points to support Segment 5 construction and removing existing roundabouts to streamline traffic flow.

This development marks a generational opportunity for Las Vegas Trail. It will improve the quality of life, provide lifesaving resources, and educate an entire community. This investment proves that anything is possible with vision and creative public/private partnerships.





The Commissioners Court proclaimed the week of September 16th, 2025, as Tarrant County Co-Responder and Crisis Responder Week. This annual proclamation highlights the critical partnership between local police agencies and the Tarrant County Law Enforcement Liaison Project, which pairs licensed professionals with officers to effectively assist individuals in crisis. The collaborative efforts of these dedicated teams not only enhance public safety but also foster compassion and understanding in addressing mental health challenges within our communities.



Triple Crown Champion Zaylyn Woods of Azle, TX Takes Wrestling by Storm

Zaylyn Woods, a freshman wrestler at Azle High School, has quickly made a name for herself by winning three national titles in the girls 14-under division since late last year. Coming from a family of mixed martial arts fighters—her mother and stepfather are former UFC competitors Mark and Montana De La Rosa—Woods has showcased her talent across various wrestling styles, including freestyle, Greco-Roman, and folkstyle.

Her impressive victories include the Brian Keck Memorial Preseason Nationals in Iowa (120 pounds), Kids Folkstyle Nationals in Indiana (115 pounds), and Women's Nationals in Washington (120 pounds). "Winning the first title builds confidence and makes me want to work harder for the next," Woods said, reflecting on her accomplishments.



With aspirations for state championships in high school, national titles in college, and possibly the Olympics, Woods embodies determination and ambition. She expressed excitement about joining the Lady Hornets, a renowned program that recently finished third at the Class 5A state tournament.

Tarrant County, Precinct Four, is proud to support young athletes like Zaylyn, who exemplify hard work and dedication. Coach Tyler Harrison believes Woods can add to the team's legacy of success, and Woods acknowledges the support of her family and coaches in her journey. As the wrestling season approaches in November, all eyes will be on this promising athlete as she aims to shine as a Lady Hornet.






Community Spotlight

Gold Star Mothers and Families Day is observed annually on the last Sunday of September, dedicated to honoring the families of service members who have lost their lives while serving in the United States Armed Forces. 
