Bates - Aston Road Repair

Precinct 4 road maintenance crews acted swiftly this week after receiving reports that Bates-Aston Road had become hazardous for drivers. The roadway is currently under construction as a third-party contractor installs a new water line beneath the surface, but unexpected conditions created an unsafe situation just ahead of the holiday weekend.

Upon receiving the call, our crews mobilized immediately and worked efficiently to stabilize the affected areas and restore safer driving conditions. Their rapid response helped ensure that residents and visitors could travel the corridor with greater confidence during one of the busiest times of the year.

As the utility project continues, Precinct 4 will remain in close communication with the contractor to ensure the roadway is maintained properly throughout construction. Once the work is complete, we will be prepared to bring Bates-Aston Road back up to the standard our community expects from a Precinct 4 county road.

We appreciate the public's patience and encourage residents to continue reporting roadway concerns so we can address them as quickly as possible.

Boys and Girls Clubs across the country help to provide critical services to thousands of our local youth. We are proud to support their efforts!



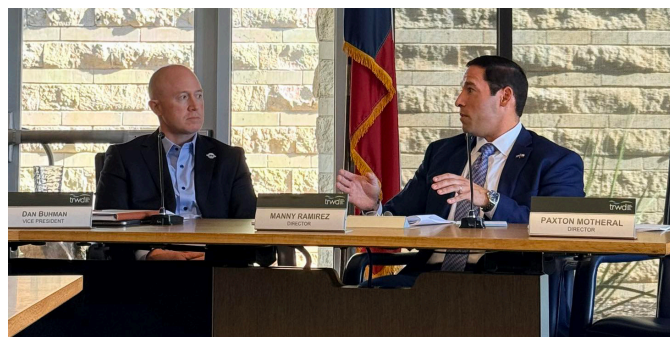
TXDOT released an update on the North Texas SH 199 Project. A key milestone was hit last month, with traffic shifting to the newly constructed eastbound SH 199 Bridge, joining the westbound traffic had been shifted earlier this year. The project is expected to be complete by Spring 2026.





After decades of strategic planning, hard work, and collaboration, notable progress is being made on the Panther Island flood project. 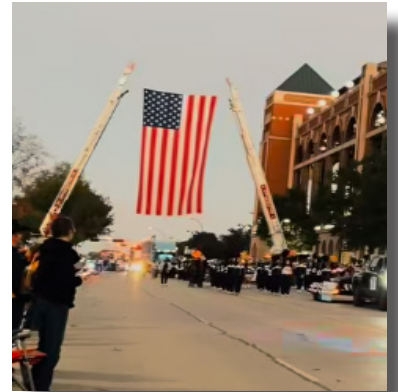

EMSISD Students Get a Head Start with Tarleton Today

Eagle Mountain-Saginaw ISD will launch Premier Pathway in the Fall of next year, in a new partnership with Tarleton State University that lets students earn up to 45 college credit hours before graduation! This dual enrollment program will allow eligible high school students to earn their Texas Core Curriculum, (45 college credit hours) all while earning their high school credit! A strategic initiative designed to help students get a head start on their college and career goals.

The program is designed to be both affordable and accessible, removing common barriers to college credit. No placement score is required to enroll in a course. Students who participate are officially enrolled as Tarleton students during the course, giving them access to university resources such as tutoring, advising, and even campus events. Courses are carefully selected to align with graduation requirements and college-readiness standards and are earned from a four-year institution at a fraction of the cost.

Suppose your student prefers one of the other great Texas Colleges, they can transfer their “core complete” status to any public institution of higher education in Texas, as guaranteed by state law under Texas Education Code Section 61.822, after having successfully completed their core curriculum and passing all required courses. Students are given the option to accept or decline the college grade and credit at the end of the course.

EMSISD is committed to ensuring that students from all backgrounds have the opportunity to participate. By embedding college courses directly into the high school schedule and using EMSISD teachers who meet Tarleton’s qualifications, the district is making dual credit more attainable than ever before, helping students to develop skills that prepare them for life after high school.

High School Teachers will also benefit from the program. Those who teach Tarleton Today courses will receive professional development and support from Tarleton faculty, helping them grow as instructors and deepen their content knowledge. This collaboration strengthens the district’s instructional quality and builds lasting partnerships between secondary and postsecondary educators.

As EMSISD continues to expand its college and career readiness efforts, Tarleton Today stands out as a cornerstone of its vision. It reflects the district’s commitment to innovation, equity, and excellence ensuring that every student has the tools to succeed in a rapidly changing world.

Northwest Tarrant's New Lifeline: NWECC Unveiled

Northwest Tarrant County has entered a new era of emergency response with the launch of the Northwest Emergency Communications Center (NWECC), a next-generation 911 dispatch facility designed to unify and modernize public safety communications serving the cities of Lake Worth, Saginaw, as well as Eagle Mountain-Saginaw ISD.

As the Executive Director of NWECC and Chief of Police, J.T. Manoushagian led the charge to create a centralized dispatch center that could serve multiple jurisdictions with speed, precision, and cutting-edge technology. This centralized system also enhances transparency and accountability, giving the public greater confidence in their local emergency services.

By partnering with NWECC, the police agencies in Lake Worth, Saginaw, and EMSISD consolidated their emergency communications into a single, integrated hub that enhances coordination, reduces response times, and improves outcomes during critical incidents. It is designated as a “next-generation 911-capable” center, which means it supports not only voice calls but also text, video, and data communications. Enhanced GPS tracking enables dispatchers to locate callers more accurately, and the system can receive photos and videos that provide crucial context for first responders.

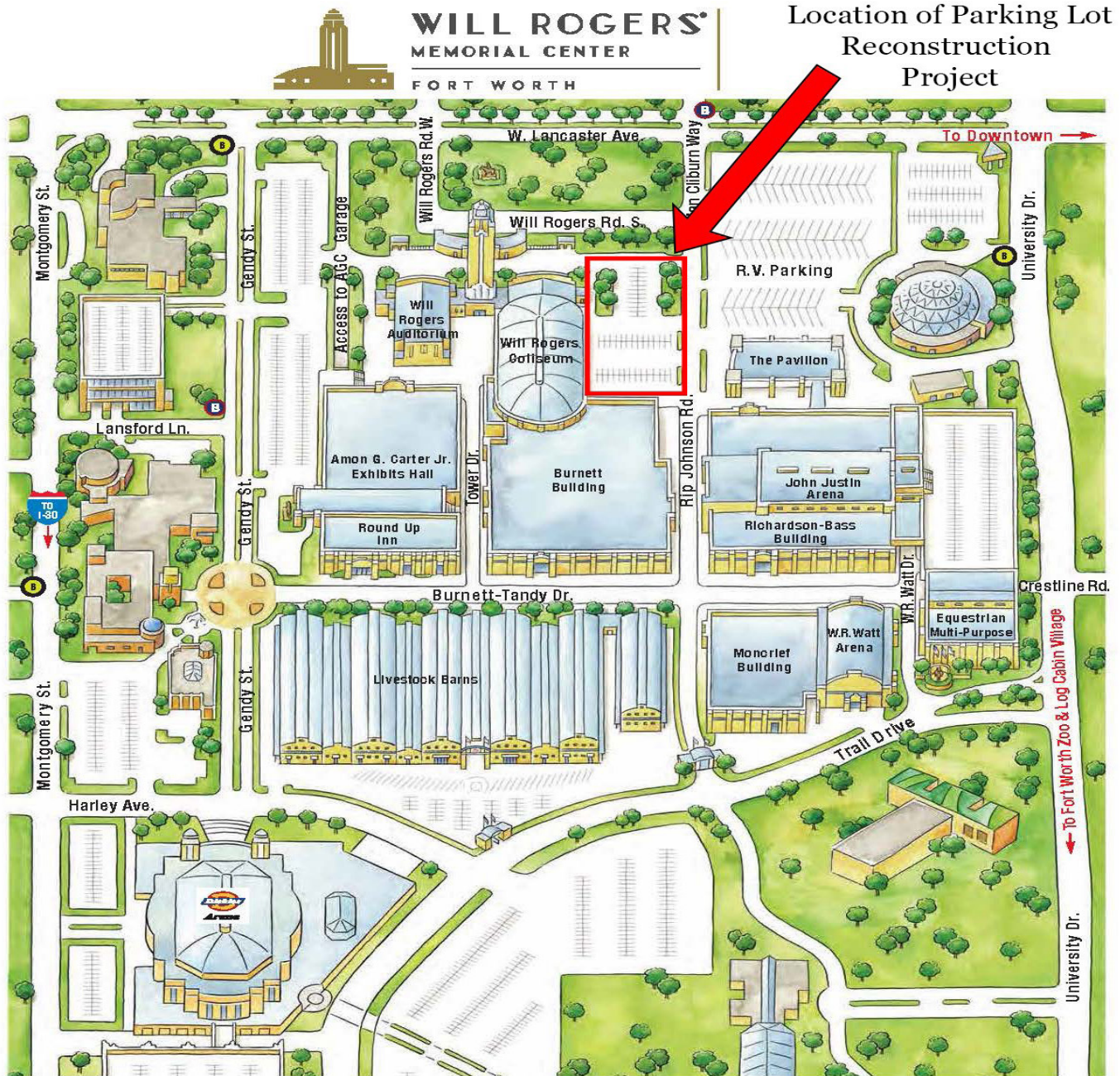
The ability to communicate more effectively as a team during emergencies leads to faster emergency response times for the community, improved communication between agencies, and a more reliable 911 service. Having protected and served our community as a police officer for over a decade, and now as County Commissioner, Manny Ramirez firmly believes that it doesn't matter what agency patch you have on your uniform; what matters is being there to help that citizen during a critical moment in an emergency.

Chief Manoushagian and the NWECC team are committed to community engagement. Public outreach efforts include educational campaigns about Text-to-911, facility tours, and presentations at schools and civic events. These initiatives aim to empower residents with the knowledge they need to use emergency services effectively and responsibly.

With the launch of NWECC, Northwest Tarrant County has not only modernized its emergency infrastructure, it has set a new standard for regional public safety. Through collaboration, innovation, and strong leadership, the region has created a lifeline that will serve its communities for years to come.
