## Comments:

In opposition to the proposed extension of the state of emergency in Tarrant County: Despite the known increase in COVID-19 cases that was anticipated to occur for the flu-like illness at this time of the year, it continues to constitute a minority of hospital ICU utilization and continues to show fatality rates that are <25% of typical rates for at-risk groups from conventional primary causes of death (e.g., heart attack, cancer, etc.). It also continues to remain less dangerous than conventional illness such as influenza for low-risk groups such as young people. Since the overall survival rate is better than 99.6% and since the continued spread of COVID-19 throughout the population is not feasible to stop with measures such as indefinite isolation or facial coverings, it would be inappropriate to declare a continued state of emergency or impose these harmful restrictions.
