## DISTRICT CLERK CORNER

Dear Legal Professionals,

Most of us are glad to see 2023 in the rearview mirror, but there were some good things accomplished.

1. A new software system (TechShare) replaced the old (1988 vintage) criminal system. That was used by the District Clerk, County Clerk, Sheriff, District Attorney, plus the judges hearing both felony and misdemeanor cases.

What an achievement! All departments collaborated fully, and a new modern system was built that is owned by Tarrant County with the ability to upgrade as needed.

2. Personnel shortages were managed that were caused by COVID and a hot job market. Good management kept everything up to our high standards of customer service with turn-around time on new filings almost always achieved the same day or early the next day at worst on late in the day filings.
3. District Clerk management generated cost savings each of the last 2 years amounting to 1.6 million dollars which was turned back to the county. Commissioners Court used that with the other cost savings to make the largest tax rate cut in memory.

Hopefully, COVID will fade away and we will be able to handle our rising case load (65,000 new cases last year) in a cost-efficient manner that fits the requirements of the law.

**Effective January 1, 2024**

Per SB1612 of Legislative Session 88(R)

### Family

- ◆ Motion to Reinstate \$80.00 (this is a **new fee**)
- ◆ Transfer of Case from Another County-SAPCR increasing from \$45.00 to \$80.00
- ◆ Motion for Contempt-SAPCR increasing from \$15.00 to \$80.00
- ◆ Motion for Modification (Motion to Modify) (Suit for Modification)-SAPCR increasing from \$30.00 to \$95.00
- ◆ Motion for Enforcement-SAPCR increasing from \$30.00 to \$95.
- ◆ Motion to Revoke a Stay of License Suspension increasing fee from \$15.00 to \$80.00
- ◆ Notice of Application for Judicial Writ of Withholding increasing from \$15.00 to \$80.00
- ◆ Petition for License Suspension increasing from \$15.00 to \$80.00
- ◆ Notice of Appeal fee being **decreased** from \$80.00 to \$35.00
- ◆ Motion to transfer \$15.00 fee **removed**.

### Civil

- ◆ Motion to Reinstate \$80.00 (this is a brand new fee)
- ◆ Notice of Appeal fee being **decreased** from \$80.00 to \$35.00

#### Amendment to TRAP Rule 24

Pursuant to the rule change effective January 1, 2024, the clerk is no longer required to review and approve a Supersedeas Bond. No bond approval fee is charged for filing a Supersedeas Bond.

Texas Rules of Appellate Procedure 24.1(b) (2): A bond is effective upon filing. On motion of any party, the trial court will review the bond.

## Inclement Weather Filing Procedure

### \*\*\*NOTICE\*\*\*

In the event Tarrant County Government Offices are closed due to inclement weather, the District Clerk's office will utilize one of the following filing procedures.

#### **Option 1 (Self-represented filed with Civil/Family cases only):**

T.R.C.P. Rule 5. Enlargement of Time \*\*If you elect to use this filing option, (on the next open hours) inform the clerk of the court in which you are filing the pleading(s) to keep the postmarked envelope.

#### **Option 2:**

Place the pleading(s) in the designated deposit box located at the information station at 401 W. Belknap, Justice Center or 200 East Weatherford St, Family Law Center.

\*\*T.R.C.P. Rule 5, Paragraph 2

If any document is sent to the proper clerk by first-class US mail in an envelope or wrapper properly addressed and stamped and is deposited in the mail on or before the last day of filing same, the same, if received by the clerk not more than 10 days tardy, shall be filed by the clerk and be deemed filed in time. A legible postmark affixed by the US Postal Service shall be prima facie evidence of the date of mailing.

#### **Option 3:**

File documents electronically through an e-filing service provider.
