## Looking back...

As we begin 2023, it is a good time to look back at changes in the District Clerk's office over the past 3 decades. While it may be thought otherwise, even in county government, change occurs "mostly" for the better. Here's a quick look...

In 1993 the District Clerk was located in 4 county buildings –

The Tarrant County Justice Center (now the Tim Curry Criminal Justice Center) opened in 1991 housing the Criminal and Civil clerks as well as the District Clerk Administrative offices.



At the time the Family Law clerks and courts were still located in the 1957 Civil Courts Building attached to the west side of the 1895 Court house. While considered advanced when built, by 1995 was needing a serious update or replacement.





The interior workspace for the clerks was in a word – bad. The ceilings and windows leaked. The floors were worn and uneven. The A/C and elevators routinely failed. However, most serious was the basement "dungeon" which at the time housed the District Clerk closed records section. Rain from even minor storms would leak into areas housing paper records.


Here are some photos from the clerk's file desk area showing file desk and mail bins –





Something needed to be done until the new Family Law Center opened. Minor improvements were made to floors and ceiling leaks, but elevators and power still failed until...

In 2005 the Family Law Center opened. More space, records out of the basement, A/C and elevators mostly worked...



So, that leaves the Civil Clerks/Courts and DC Administrative offices to move into the Tom Vandergriff Civil Courts Building in 2015.



In 2023 the District Clerk opened new offices, (4<sup>th</sup> location) for Juvenile court staff in the Scott D. Moore Juvenile Justice Center.

The Felony/Civil section of the District Clerk's office handles Expunctions, Non-Disclosures, Occupational Driver's License, Seizures and Bond Forfeiture cases.

It is located on the 3<sup>rd</sup> floor of the Tim Curry Justice Center. The Felony/Civil section currently accepts electronically filed documents for Expunctions, Non-Disclosures, Felony Occupational Drivers Licenses, Bond Forfeiture (NISI's) and Seizure cases <u>only</u>.
