As usual, the Texas legislature made some changes in the statutes that will affect our office as well as at least part of the legal community.

Please note, that a major fee increase was obtained from the legislature by the Office of Court Administration on e-Filing. This fee was raised from \$20 to \$30. **None of this fee goes to the county government**. All of it goes to the OCA to pay for the e-Filing vendor's application.

Please consult the District Clerk section of <u>www.tarrantcounty.com</u> for current fees. Other legislative changes can be accessed through Texas Association of Counties and other sources. Be sure and note the effective date of the new statutes. **Not all** of them began September 1, 2015.

Finally, we had to delay the implementation of our planned October 1, 2015 "paperless court" initiative due to technical circumstances beyond our control. After these issues are resolved, we will make another effort to get away from paper files as per Rule 21(f)(13) of the Supreme Court rules on e-Filing.

# Efile Fee Increase Effective 9-1-2015

If you have noticed an increase in the felony/civil costs, you are correct. Due to



SB1139 the e-filing fee of \$20 dollars was increased to \$30, effective 9-1-2015. This fee will affect the felony/civil area and will increase the civil

filing fees for Expunctions, Non-Disclosures and Occupational Drivers Licenses. Should you have any questions please contact the felony/civil area at 817-884-2508.



# Be on the lookout....

There is a fee increase (HB 2182) that will be effective on January 1, 2016. The jury fee increases to \$40.

SECTION 5. Section 51.604(a), Government Code, is amended to read as follows:

(a) The district clerk shall collect a \$40 [\$30] jury fee for each civil case in which a person applies for a jury trial. The clerk of the county court or statutory county court shall collect a \$40 [\$22] jury fee for each civil case in which a person applies for a jury trial. The clerk shall note the payment of the fee on the court's docket.

When filing a Motion and Proposed Order, do not file the Order as a Lead document. The

Proposed Order does not require a file-mark. Instead, file it as an attachment in e-filing.

# Fee Increase Due to a Legislation Change Effective September 1, 2015

SB 1139 - Fee increase effective 9/1/15.

Increases the electronic filing fee from \$20.00 to \$30.00 in civil cases in the appellate, district, and county-level courts. See § 51.851(b), Gov't Code.

SECTION 4.01. Section 51.851(b), Government Code, is amended to read as follows: (b) In addition to other fees authorized or required by law, the clerk of the supreme court, a court of appeals, a district court, a county court, a statutory county court, or a statutory probate court shall collect a \$30 [\$20] fee on the filing of any civil action or proceeding requiring a filing fee, including an appeal, and on the filing of any counterclaim, cross-action, intervention, interpleader, or third-party action requiring a filing fee to be used as provided by Section 51.852.

# E-Filing Helpful Hints

Since the E-filing system was put into place beginning of January 1, 2014, the Tarrant County District Clerk's office is always trying to find new ways to make this process run a little more efficiently and a little more smoothly with each filing that is received. We do have some helpful hints in hopes of getting your filings accepted and processed into our system with a little more ease.

#### E-Filing Helpful Hints Cont'd...

When submitting e-filings for initial or subsequent cases in the Civil District Courts, please do

not fill in any attorney information for anyone other than the party you are representing. Respondents/ defendants attorney information <u>should not</u> be filled in when opening a new case. This information has to be left blank until something has been submitted in writing on their behalf.



When filling out the plaintiff's information in the e-filing system (address, telephone number, etc.) do not use your law firm's address. We will <u>only</u> use the information that is stated in your petition, any other information will be removed from our system. This includes but is not limited to the defendants' information. We will continue to edit the citation(s) with any service addresses provided from the citation request form.

When serving a defendant through the **Secretary of State**, **Commissioner of Insurance**, or **Texas Department of Insurance**, it is not necessary to use the addresses of these entities in the defendants' party information section. The service address needed in this section is the one these entities will actually attempt service. Also, don't forget that for each of these entities, two file-marked copies of the pleading and an extra 2 page copy fee of .70 (second copy of the citation produced) is needed to complete your citation request for each defendant being served by and through these entities. You may provide these copies or pay through the e-filing system but the 2 page copy fee (.70) is always required for the second issuance of the citation.

When requesting these citations through these entities from the <u>"Optional Services"</u> drop down box, please select from the following:

"Issue citation-Secretary of State (\$8.00)" "Issue citation-Insurance Commission (\$8.00)" "Issue citation-State Highway Commission (\$8.00)"

For service by certified mail, please request "Service-Certified Mail (\$75.00") for each defendant specified.

#### Filing Application for Foreclosures

When filing a foreclosure case and requesting citations to be issued and served by certified mail (\$83.00) and standard first class mail. **This includes the \$8.00 citation fee as well as the \$75.00 service fee**. It is however, not necessary to request regular citations (\$8.00) in addition to the citations with certified mail service. This type of citation not only includes the language needed for notifying the respondents of foreclosure within a 38 day response time, it automatically produces the second copy of the citation to be served through first class mail.

We hope that the information that we have provided will prove to be advantageous in your prospective e-filings with the Tarrant County Civil District Clerk's office.




# Criminal Clerk Reassignments
