## When will Tarrant County E-Filing begin?

Tarrant County will begin E-Filing all Subsequent Documents for Criminal cases on January 1, 2018.

### Do I need an E-Filing account or service provider?

# Are there fees associated with E-Filing Criminal documents like there are with Civil and Family filings?

There are no fees associated with E-Filing of Criminal documents.

## What are the requirements for an E-Filed document to be accepted on a Criminal case?

Missing items that may prevent acceptance of a document are Case Number, Attorney Name, Attorney Address, Attorney Phone Number, Attorney Email Address etc.

# Do Proposed Orders (Orders unsigned by the Judge as part of a Motion) require a cover letter as a lead document?

Yes, please file any Proposed Orders as an Attachment to the Lead document or within the Lead document behind the Motion.

## What is the format for E-Filing a Criminal document?

When E-Filing a Criminal document, please refer to the statewide eFiling Rules for Criminal Cases at <a href="http://www.txcourts.gov/jcit/electronic-filing/">http://www.txcourts.gov/jcit/electronic-filing/</a>. All E-Filed documents should be in Text Searchable PDF format.

### Are there documents that are not required to be E-Filed?

Certain documents will continue to be filed in current form. Examples are Letters of Representation (Atty Rep Letters), Plea Papers and Initial Case Filings.

## Are there Kiosks inside County offices to E-File Criminal documents?
