## Benefits of enrolling in the IV-D program

- Free income withholding orders issued and delivered to employers.
- Free up to date pay records with account balances.
- Free and automatic case closures when support is paid in full and all children have emancipated.
- Free administrative enforcement of child support and medical support orders without going to court.
- Free child and medical support reviews are conducted regularly.
- Free case referrals for modifications and enforcement to Tarrant County DRO Legal Support Services.

## Costs to you by not enrolling

- \$15 fee for issuing and delivering each income withholding order.
- \$25 for each pay record with account balance.
- \$65 to close the account after you notify us that support is paid in full and all children have emancipated.
- No administrative remedies available.
- Pursue a new court order at your own cost.
- Pursue a new court order at your own cost.



By enrolling in the Monitoring Program, we will utilize all the resources available to us to attempt to locate a non-custodial parent and to collect child support through income withholding, income tax refund intercept, and other collection methods, including legal action.
