NOTE TO TARRANT COUNTY ELECTIONS ADMINISTRATOR:

This ballot language will be used for the Lakeside election, as noted above, one for the registered voters/residents of Tarrant County Emergency Services District No. 1 with two propositions, one for the registered voters/residents of the Lakeside area to be annexed (“Lakeside Defined Territory”) with two propositions. The voters of both areas, the District and the Defined Territory, will vote on the same propositions, but will need to be coded or segregated into District voters and Defined Territory voters. Please call with questions, as it is essentially three elections, with the District voters voting on whether the Defined Territories come into the District and the voters of the Defined Territories voting on coming into the District with the two propositions set forth, above. Also, please verify my Spanish translations of the ballot propositions, but this is the language required by statute. When I say “verify,” just please see if I have a typo or something I missed or it flat does not make sense.
