**CRIMINAL PAYMENTS**

**Adult Defendants Only: Telephone and on-line payment are available only to criminal defendants age 17 and over, for criminal offenses committed after age 17.**

**Payment constitutes a plea of Nolo Contendere ("No Contest") [Texas Code of Criminal Procedure, Article 27.14 (c): "In a misdemeanor case for which the maximum possible punishment is by fine only, payment of a fine or an amount accepted by the court constitutes a finding of guilty in open court as though a plea of nolo contendere had been entered by the defendant and constitutes a waiver of a jury trial in writing."].**

**Important Note: We accept the full amount only.**

- Call the Clerk of the Court at 817-884-1395 for the exact amount to pay. Failure to do this could result in your payment being returned.
- Phone and Internet transactions will be posted the day after entry.
- If there has been a warrant issued for your arrest, it will not be recalled until the day after your payment is posted.
