## **Occupational Driver's License – What you need to know**

An Occupational Driver's License (ODL), also called an essential need license, is a special type of restricted license issued to individuals whose driver's license has been suspended, revoked or denied for certain offenses other than medical or delinquent child support.

An Occupational Driver's License (ODL) authorizes the operation of a non-commercial motor vehicle in connection with an individual's:

- Work
- School-related activities **OR**
- Performance of essential household duties

## **Request an Occupational Driver's License**

Requests for an Occupational Driver's License must be made to the justice, county or district court where the individual resides or to the court of original jurisdiction where the offense occurred.

- The petitioner MUST file in the county they reside or the county where their driver's license was suspended
- A petitioner can have 2 ODLs within a 10 year period
- The suspended license must be a Texas driver's license
  - A petitioner can NOT apply for an ODL if they have never had a Texas driver's license
- Justice Courts DO NOT have jurisdiction over suspension for DWI, medical advisory issues, mental issues or child support issues

## Before filing check your eligibility status

You must show a NOT ELIGIBLE status to file for an ODL

- Original Petition
- SR-22 (financial responsibility insurance certificate)
  - A declarations page will not be sufficient

### Once the ODL has been granted by the Judge

- The court will provide the petitioner with:
  - 1 certified copy of the petition
  - 2 certified copies of the order
  - Driving log (if required)
  - AA log (if required)
- The petitioner MUST submit the following items to DPS immediately as the order is only valid as your driver's license for 45 days:
  - A certified copy of the petition
  - A certified copy of the order
  - $\circ$  The SR-22
  - Payment of the occupational driver's license fee
