G.K. Maenius Celebrates Retirement after 35 Years of Service

G.K. Maenius began his 35 years of service at Tarrant County in 1988. He was the first and only person to serve as County Administrator during that time. Tarrant County currently employs over 4,600 individuals and works with a \$900 million dollar Operating Budget. The county population has doubled from 1.1 million in 1988 to 2.2 million in 2022.

Maenius supervised County departments including Budget and Risk Management, Community Development. Dell DeHay Law Library, Facilities Management, Human Resources, Human Services and Information Technology. The County Administrator also guides public meetings and makes sure procedures are followed based on rulings of County Commissioner's Court.

Maenius played a crucial role in the development of the AT&T Stadium in Arlington, the Alliance corridor, expansion of the American Airlines headquarters in Fort Worth and the partnership between Fort Worth and the Texas A&M campus expansion, located downtown.

Maenius is a Texas native and graduated from Texas State University with a master's degree in Public Administration.

## **Texas Law Help: Mitigating the Justice Gap**

The Self-Represented Litigation Network estimates that **three out of every five civil cases in the United States are represented by** *pro se* **litigants.** Most of the changes in the United States Courts have taken place over the past decade. According to a study conducted by the Legal Services Corporation, low-income Americans do not receive any or enough legal help for 92% of their civil legal problems, which includes serious issues such as housing, child custody, health care, and safety.

The statistics for lack of access to justice worldwide are alarming as well. In 2019, the World Justice Project estimated that "more than 5.1 billion people, about two-thirds of the world's population, are not getting the justice they need for both everyday problems and severe injustices, and approximately 1.4 billion people have unmet civil or administrative justice needs," (World Justice Project, <a href="https://worldjusticeproject.org/sites/default/files/documents/WJP-A2J-2019.pdf">https://worldjusticeproject.org/sites/default/files/documents/WJP-A2J-2019.pdf</a>).

The Texas Law Help website (<a href="https://texaslawhelp.org/">https://texaslawhelp.org/</a>) is a collaborative effort by various legal aid associations, courts, and nonprofits that provides free legal information for pro se litigants in an effort to mitigate the justice gap. In the last year alone, more than 4 million individuals have accessed the Texas Law Help site in order to retrieve free legal guides, forms, directories, and contact information for legal clinics.

Legal aid organizations provide assistance for more than 140,000 Texas families each year. According to the Texas Access to Justice Foundation, approximately 5.2 million Texans qualify for free legal aid. An individual must not earn more than \$16,988 per year and a family of four must not earn more than \$34,688 per year. There is approximately one legal aid lawyer for every 7,000 Texans who qualify. Texas ranks 46th in access to legal aid lawyers.
