Who Was Dell DeHay?

Dell DeHay served as the Tarrant County Law Librarian from 1962-1979. She was the third librarian to serve since the official opening on October 1, 1945. DeHay was an active member of the American Association of Law Libraries (AALL) and the Southwestern Association of Law Libraries (SWALL), serving as its Secretary -Treasurer for 9 years, 1967-1976.

DeHay was born Alma Adelphia Markward on October 26, 1918 in Miami, Arizona. The family moved to Fort Worth shortly after her arrival, where her father became well known in the community as the Vice President of Fort Worth National Bank. DeHay, only 12 years old at the time, tragically lost her mother due to an inoperable brain tumor.

DeHay graduated from Polytechnic High School and attended Texas Wesleyan College, earning a degree in English that would be the foundation for her law librarian career.

She married Larry DeHay, a jeweler, upon graduation. Their family resided in Corpus Christi for several years, and DeHay began raising their two children (see image below).



The family moved to Fort Worth, and DeHay began her career as a Tarrant County Law Librarian in 1962. She worked primarily alone, and attended school in the evenings for her MLS degree at North Texas State University, now officially named University of North Texas. DeHay was a strong student and selected for membership in the Honor Society.



DeHay was diagnosed with cancer in 1975 and hired a part time assistant, Frances Perry. In 1977, a consultant hired by the Law Library Committee for purposes of evaluation credited her with building one of the top law libraries in the state.

DeHay was forced into early retirement due to her health and passed away six weeks later on June 12th, 1979. Eight days before her passing, the Tarrant County Law Library was renamed in her honor by the Tarrant County Court Commissioners Court (see image above). Perry would officially become the fourth Law Librarian in December 1979.

Perry wrote a memorial for the Texas Law Journal in 1980 commending DeHay as "gracious and kind, with a genius for being helpful. At the same time she possessed a drive and determination surprising in one of her good nature and petite stature...we who knew her will carry her image in our hearts and her influence in our lives."

## **EARLY TIMELINE OF DELL DEHAY LAW LIBRARY**

## 1944

- November 20, 1944 Commissioners' Court passed resolution creating Tarrant County Law Library
- December 1, 1944 Effective date of Commissioners' Court resolution
- Homa S. Hill, referred to by some as the "Father of the Law Library," became the first Chairman of the Library Committee

#### 1945

- May 17, 1945 George W. Steere chosen as the first Law Librarian
- July 1945 Law Library's Rules and Regulations adopted by Commissioners' Court
- October 1, 1945 Library officially opened to the public (located in 1895 Courthouse)

## 1948

- George W. Steere passed away
- Gueneth A. Babcock became the second Law Librarian

#### 1958

 Law Library and Court of Appeals moved to second floor of old Civil Courts Building

#### 1962

- Temporary, acting librarian, Alice Heaton, took over duties in the Law Library during Babcock's illness
- Gueneth A. Babcock passed away
- Dell DeHay became the third librarian and the first professional Law Librarian to serve at Tarrant County Law Library
