88th Legislature (2023): Effective Dates for Bills

New Forms, Procedures, and Resources

- Standardized Protective Order Forms: The 88th Texas Legislature passed Senate Bill 48 which required the Office of Court Administration (OCA) to created standardized forms for the application and issuance of protective orders. The new protective order forms are now available at <u>https://www.txcourts.gov/rulesforms/standardized-protective-order-forms</u>.
- **TRAP RULE 24 Update**: Pursuant to the rule change effective January 1, 2024, the clerk is no longer required to review and approve a Supersedeas Bond. No bond approval fee is charged for filing a Supersedeas Bond. Texas Rules of Appellate Procedure 24.1 (b)(2): A bond is effective upon filing. On motion of any party, the trial court will review the bond.

Library Announcements

45th Anniversary of Law Library Naming



June 4, 2024, marked the 45th anniversary of the Tarrant County Law Library becoming the Dell DeHay Law Library of Tarrant County. Who was Dell DeHay, you might ask? Born in 1918, Alma Adelphia "Dell" (Markward) DeHay began working at the Tarrant County Law Library in 1962 and has the distinction of being the Law Library's first professional librarian. From 1964 to 1969, she worked nights and Saturdays to achieve her master's degree in library science. Dell DeHay transformed the Law Library over her sixteen years of service. She is credited with enhancing the Law Library's collection. Under her direction, the library became known as "outstanding

for a working law library, with practically all areas of law presented therein." Rumor has it that she had the gumption to send taxies to law firms to retrieve overdue books – back when books were allowed out of the library – and billed the firms for the fare both ways. They reportedly paid it too!

By 1976-1977, Dell DeHay and the Law Library had received some well-deserved accolades. DeHay was dedicated to the Tarrant County legal community, and she received the Fort Worth-Tarrant County Young Lawyers' Association Mentor Award in 1976. An independent review of the Law Library conducted on April 23, 1977, declared the library as "well-managed, with an outstanding collection." The reviewer declared, "There [were] no established 'standards' for county law libraries in the United States, but if there were, Tarrant County Law Library would measure up in all respects." She concluded that DeHay "probably ranks in the top ten percent of law librarians in the United States."

The review also was published in *The Bar News*, prompting even more letters of congratulations. Attorney Ruel Hudspeth also told the Library Committee Chairman "with all sincerity" that he had "never met two more capable and courteous librarians than Mrs. DeHay and Mrs. Perry," and he joked, "I earnestly wish they would offer to try some of my cases for me! Maybe I'd win a few."

Sadly, despite her professional successes, DeHay's health deteriorated rapidly during the late-1970s, and she had to retire early. In honor of her many years of service, and in recognition of her commitment to the Law Library, the Commissioners Court named the Law Library after her on June 4, 1979. She passed away a few short days later, on June 12, 1979, and is buried at Shannon Rose Hill Cemetery in Fort Worth. The Dell DeHay Law Library of Tarrant County carries her name and her legacy to this day.

- Legal Aid of Northwest Texas (LANWT) is income based legal aid for residents of Northwest Texas. Visit www.lanwt.org to apply online. Applications are available in English and Spanish. Call 817-336-3943 to apply if you are involved in a family law case, domestic violence situation, have a legal deadline, and/or have been served a lawsuit.
- **Tarrant County Bar Association Lawyer Referral Service**. Call 817-336-4101. The attorneys in this referral program have agreed to 30-minute consultations for \$20.00. You are not obligated to retain the attorney after the initial meeting.
