Tarrant County DRO Hosts Family Law Workshops

Tarrant County Domestic Relations Office (DRO) began hosting Family Law Workshops in March 2023. The DRO provides child support, legal support and family court services for Tarrant County. Texas A&M University School of Law in Downtown Ft. Worth will be co-hosting the workshops with the DRO beginning in 2024.

DRO staff are not able to provide legal advice, however, they are able to provide information in regard to court procedures. The staff can explain how a case starts, when it ends, answer questions about the child support process, explain conservatorship, explain possession and access, and what can happen in a case. They’re also able to answer similar questions in regard to non-family civil cases. Workshops don’t cover procedures for criminal cases.

Location: Tarrant County Courthouse on the 3rd floor in the Law Library’s Conference room.

Beginning in January 2024, the workshops will be the 1st and 3rd Thursdays at 10am. *Exceptions: The months of July and November will each have only 1 workshop.*

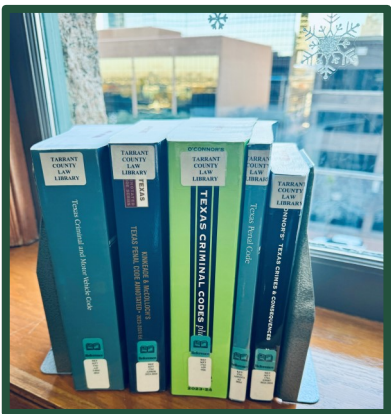
Happy 5 Year Work Anniversary, Cara!

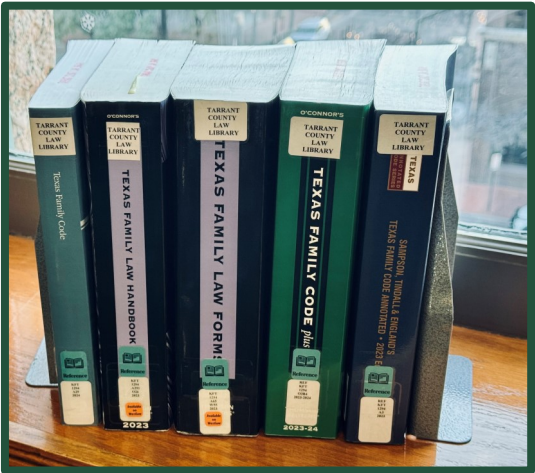

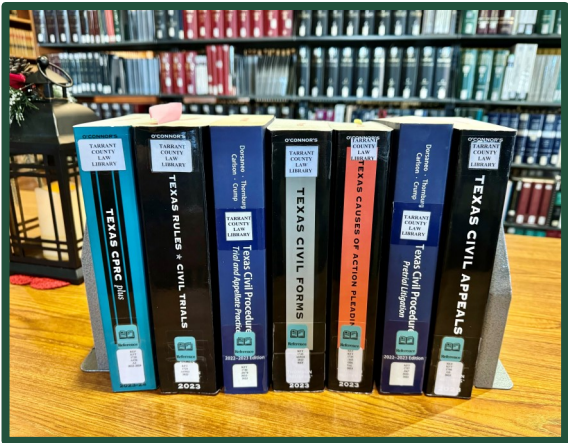

- **Tarrant County Bar Association** provides attorney referral services. **Call 817-336-4101.** The attorneys in this referral program have agreed to 30 minute consultations for \$20.00. You're not obligated to retain the attorney after the initial meeting.
