# Affidavit of Heirship Research Guide

### **Overview**

This research guide includes information and resources on affidavit of heirship. An affidavit of heirship is a sworn statement averring that someone is a decedent's heir under a state's intestacy law and is entitled to inherit some or all of the decedent's property (*Black's Law Dictionary, 11th ed.*). This guide does not cover Determination of Heirship procedures, which is a separate but similarly named form of probate procedure.
