

Affidavits and Declarations (Family Law) Research Guide

Overview

This research guide includes information and resources on some of the most common affidavits and declarations related to family law. Both affidavits and declarations are types of sworn statements. An affidavit is “a voluntary declaration of facts written down and sworn to by a declarant, usually before an officer authorized to administer oaths,” like a notary. A declaration is “a formal statement, proclamation, or announcement, especially one embodied in an instrument.” (*Black Law Dictionary, 11th ed.*) The resources listed below are not exhaustive and may not include the most up-to-date information.
