

Bankruptcy: Automatic Stays Research Guide

Overview

This research guide includes information and resources on automatic stays in bankruptcy cases. An automatic stay is “a bar to all judicial and extrajudicial collection efforts against the debtor or the debtor’s property, subject to specific statutory exceptions. The policy behind the automatic stay, which is effective upon the filing of the bankruptcy petition, is that all actions against the debtor should be halted pending the determination of creditors’ rights and the orderly administration of the debtor’s assets free from creditor interference.” (*Black’s Law Dictionary*, 11th ed.)
