### **Overview**

This research guide includes information and resources on birth certificates. A birth certificate is "a formal document that records a person's birthdate, birthplace, and parentage." (*Black's Law Dictionary, 11<sup>th</sup> ed.*) Birth records in Tarrant County are filed with the Vital Statistics office of the County Clerk and sent to Vital Statistics in Austin, Texas.
