

# Criminal Trespass Research Guide

## Overview

This research guide includes information and resources on criminal trespass. "A person commits an offense if the person enters or remains on or in property of another, including residential land, agricultural land, a recreational vehicle park, a building, a general residential operation operating as a residential treatment center, or an aircraft or other vehicle, without effective consent and the person: (1) had notice that the entry was forbidden; or (2) received notice to depart but failed to do so." (*Texas Penal Code §30.05*) The resources listed below are not exhaustive and may not include the most up-to-date information.
