# Foreclosure Research Guide

## **Overview**

This research guide includes information and resources on foreclosure. A foreclosure is a "legal proceeding to terminate a mortgagor's interest in property, instituted by the lender (the mortgagee) either to gain title or to force a sale in order to satisfy the unpaid debt secured by the property."
