Overview

This research guide includes information and resources on right of survivorship. Right of survivorship refers to “a joint tenant’s right to succeed to the whole estate upon the death of the other joint tenant.” It is also termed *jus accrescendi*. (*Black’s Law Dictionary*, 12th ed.) The resources listed below are not exhaustive and may not include the most up-to-date information.
