# Trusts Research Guide

## **Overview**

This research guide includes information and resources on trusts. A trust provides "an extremely versatile and flexible way to administer property during a client's lifetime or after a client's death." The five basic elements of a trust are for a (1) grantor to transfer (2) property to a (3) trustee with the intent that the trustee hold the property for one or more (4) beneficiaries according to the (5) instructions of the grantor. (Davis's Texas Estate Planning Forms) As an example, an inter vivos trust, also known as a "living trust" is "a trust that is created and takes effect during the settlor's lifetime." (Black's Law Dictionary, 11th ed.) The resources listed below are not exhaustive and may not include the most up-to-date information.
