Affidavit of Non-Prosecution

An Affidavit of Non-Prosecution is "an affidavit in which a crime victim requests that the perpetrator not be prosecuted." (*Black's Law Dictionary*, 12th ed.). However, "the prosecution is not obligated to dismiss the case merely because the affidavit is executed." (*Texas Criminal Practice Guide* § 70.105).

Note: An Affidavit of Non-Prosecution must be signed in front of a notary.

To submit an Affidavit of Non-Prosecution in Tarrant County, it is recommended that you call ahead to schedule an appointment, as meeting with an Assistant District Attorney (ADA) is required. While you are welcome to visit the office in person, an appointment ensures that the ADA will be available to meet with you.
