PHAB and only the second in the state - behind the City of Houston. By obtaining national accreditation status, TCPH ended 2015 as one of the first 100 accredited public health departments in the nation, and among the top three percent of all public health departments

The TCPH North Regional Laboratory ran a record 5,043 mosquito pool tests during the 2015 season. Historic rainfalls in the Spring resulted in a later start to the West Nile Virus season, with positive pools and ground spraying efforts heating up during the summer. TCPH reported several dozen cases of WNV, with only one death for the season. As the Chikungunya virus crept up through the Americas, TCPH epidemiologists stayed vigilant for the likely arrival of this new tropical disease.

PROJECTS BORN



Live Tobacco Free became the only FREE education-based resource to help residents in Tarrant County quit nicotine.

Better Health, Better Business launched in March as a FREE service to help local businesses improve employee health.



POLICIES ENACTED



TCPH led the way and became the first Mother-Friendly Worksite county in the state.

SOCIAL MEDIA LAUNCHED



TCPH launched the Twitter handle @TCPHtweets in March, becoming verified in weeks, making it an official voice.

The department debuted an expanded social media lineup including YouTube, Instagram, LinkedIn and QR scan codes.



BEST PRACTICES ADOPTED



During Ebola, staff developed a computer-aided dispatch system to share information with first responders, now used statewide.


