



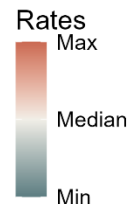

Minimum, Median and, Max are now determined based on the case rate relative to the other years rather than the case count to account for changes in the county's population size. Rates are only calculated when 20 or more cases have been reported year to date.

Less than five reports (1-4) are suppressed. Data are provisional and subject to change.
