"ALPHA Pod" Tests County's Emergency Preparedness, Communications

(March 2019) In early March, Public Health's Emergency Preparedness staff held a drill to simulate a set up of an "Alpha" point of dispensing (POD) site at the Resource Connection gym in Fort Worth. The POD would be the primary location for the coordination and dispensing of staff, equipment and medications to outlying locations should a public health emergency arise locally. Municipal emergency managers, representatives from police and fire departments and other emergency response personnel from Tarrant, Dallas, Denton and Collin Counties were invited to observe. Set up time for the POD came in at just under 10 minutes.

The occasion was also a test of the Public Health Information Network (PHIN). The PHIN is a communications system consisting of alert messages sent simultaneously by radio, phone, text and email. This test involved alerting Public Health staff that the Alpha POD was to be activated, that their presence

successful, with 100% response from all staff.

Public Health Confirms First Measles Case

(March 2019) The first case of measles in Tarrant County since 2015 was confirmed by Russ Jones, Chief Epidemiologist for Tarrant County Public Health (TCPH). The person had traveled out of the country to an area experiencing an outbreak measles.



Dallas Health and Human Services contacted TCPH's

Services contacted TCPH shortly afterward regarding their first measles case and began joint contact investigations with TCPH. The investigations linked both cases and the people involved were able to take action that minimized exposure to others.

Award-Winning Teen Videofest Program, Now in 20th Year



(April 2019) Teen Videofest,
Tarrant County Public Health's
award-winning program
promoting teen health, held its
award ceremony during National
Public Health Week. A total of
168 participants from four schools.

three independent school districts and two teen organizations submitted a total of 51 videos addressing health topics such as: bullying, depression, sexually transmitted infections and underage drinking. The program has received a "Best Practice" award from the National Association of County and City Organizations. This year also marked the 20th anniversary of this program.

West Nile Virus+ Mosquito Pool Found in Colleyville



(June 2019) The county's first West Nile Virus-positive (WNV+) mosquito pool for 2019 was confirmed in a water source in the City of Colleyville.

During 2019, Public Health's North Texas Regional Laboratory tested over 5,000 mosquito pools in Tarrant County, finding WNV+ pools in Colleyville, Euless, Fort Worth, Keller and unincorporated Tarrant County. In unincorporated areas, Public Health ground sprays for mosquitoes within days of a positive finding.

There was only one human case of West Nile Virus in Tarrant Country for 2019.



Public Health Conducts Large Scale Immunization Events

(July 2019) In conjunction with the Immunization Collaboration of Tarrant County, Tarrant County Public Health will offer back-to-school immunizations from Aug. 3 to 30.

Parents are always urged to get their children vaccinated before the school year starts.

For 2019, immunization events were held in White Settlement, Bedford, Arlington and Fort Worth. In just one day, more than 400 immunizations were given at the Family Life Gym in Arlington. More than

5,500 people were seen during August.

Public Health provided up-to-date information on its website regarding the vaccinations required for each grade, as well as hours of operation and addresses to the various locations where shots were offered. Tarrrant County Public Health also maintains an immunization registry to facilitate the storing of immunization data for individuals in

Tarrant County and makes "shot record" data available to individuals as needed for a nominal cost.



Nurse-Family Partnership Program Graduates 28 New Mothers

(August 2019) Tarrant County Public Health graduated 28 young mothers from their Nurse-Family Partnership program this month. The program teams first-time expectant mothers with experienced nurses to help them prepare for birth and improve the birth outcomes of their babies. Nurses will usually stay with their client mothers and their families for two years.



Public Health Hosts First Local Human Trafficking, Domestic Violence


