







ONLINE/PHONE TRANSACTIONS JULY 1 - SEPTEMBER 30, 2025




IN OFFICE TRANSACTIONS JULY 1 - SEPTEMBER 30, 2025

PROPERTY TAX HALF PAYMENT OPTIONS:

To Qualify, make at least the first half payment on 2025 taxes by November 30. The payment must be received or postmarked by **November 30, 2025**. Split payment in two! The remaining balance must be received or U.S. postmarked by **June 30, 2026*** to avoid penalty and interest.

*You can choose to make the remaining half payment in one lump sum or in multiple partial payments, as long as the second half is paid in full no later than June 30, 2026. If the second half is not paid by June 30th, 12% penalty and 1% interest will be added and will continue to accrue at 1% per month.

How to Renew Your Texas Vehicle Registration

Learn more about your renewal options below. Amber suggests online services when possible. It is the most popular and most convenient. If you need your registration in a hurry, in person is best.

Renew by Mail

This option is available to vehicle owners who receive a paper renewal notice.

If you did not receive your renewal notice, please call 817-884-1100 for mailing options and a price quote.

Please allow up to three weeks for your sticker to arrive by mail.

When mailing please send the following documents to our main office at 100 E. Weatherford Street, Fort Worth, TX 76196:

- Your renewal notice (keep the owner's section for your records) OR the license plate number and Vehicle Identification Number (VIN).
- A copy of your passing emissions only inspection for gasoline powered vehicles aged 2-24 years old.
- · Proof of current liability insurance.
- Payment for all fees listed on the notice. Make check or money order payable to Rick Barnes.

After renewing online, there is a two-business-day processing hold before your new sticker is printed.

Please allow up to three weeks for your sticker to arrive by mail.

You can renew your vehicle registration up to 90 days before it expires or within 12 months after, as long as you haven't received a ticket for expired registration.

Your expiration month will stay the same.

Renew in Person

Branch locations are open Monday through Friday, from 8:00-4:30, with closures for County holidays.

Please bring the following with you.

- Your registration renewal notice, your license plate number, your Vehicle Identification Number (VIN), or a prior year's registration receipt.
- Proof of current liability insurance.
- Proof of passing emissions only inspection for gasoline powered vehicles aged 2-24 years old.
- · Payment for all fees listed on the notice. Make check or money order payable to Rick Barnes. We also accept cash, debit and credit cards. Please note: a convenience fee will be charged by our credit card processor for debit/credit card payments.



Strongest Recommendation: Visit a Tax Office With the Buyer

Benefit: This ensures a smooth title transfer process and allows for immediate resolution of any last-minute issues that might arise when submitting the title application. Plus, you will meet some of our friendly and helpful employees!

Provide Your Buyer With These Documents:

- Properly assigned vehicle title: Remember, only the owner(s) listed on the front of the title can legally assign it.
- Completed Application for Texas Title and/or Registration (Form 130-U).
- Any other necessary documents, such as a power of attorney or an original release of lien

Purchasing a Vehicle from a Licensed Texas Dealership

If you have recently purchased a vehicle from a licensed Texas dealership and it has been more than 30 days without confirmation of your tax, title, and license (TTL) processing status, please contact your dealership directly for an update.

If your dealership provides conflicting information, has stopped responding to your inquiries, or fails to complete the transaction within the designated timeframe, it is important to report the issue to the TxDMV Dealer Enforcement Division. This office investigates complaints against licensed motor vehicle dealers in Texas.

GOODBYE PAPER TEMP TAGS, HELLO METAL LICENSE PLATES

Starting July 1, 2025, Texas switched to metal license plates at the time of sale to fight fraud and car theft.

Good News for Car Buyers

For customers purchasing a vehicle from a Texas dealer, you'll experience a welcome change!

You'll now drive away from the dealership with your metal license plates already attached to your new vehicle. And if you're trading in a car, you have choices for your old plates: you can transfer them to your new vehicle, have the dealership handle their disposal, or even keep them as a keepsake.

Dealer-Issued Stickers

Once your tax, title, and license transaction has been processed, the dealership is responsible for providing you with your registration sticker after they process your title transfer with the county tax office. The Dealer will either mail the sticker to you or arrange for in person pickup, depending on their process. If you're waiting on your sticker it's best to check with your dealership first before contacting the tax office.

If your sticker is lost in transit, you may apply for a replacement at your local county tax office for a fee of \$6.50.

The Motor Vehicle Team Shows What Happens When Passion Meets Purpose

More than 2.4 million webDEALER transactions have been processed by our Motor Vehicle team since the inception of webDEALER in 2014, making us second in the State for webDEALER processing. Our specialists are experts and dedicated to a 72 hour turnaround for dealers. In July, webDEALER became mandatory for all dealers. License plates and stickers are now only issued from the dealer.

Never run out of inventory! Dealers can now order plates from the TxDMV's Inventory Management System. Bonded dealers should request by emailing <a href="mailto:taxsupplyorders@taxsupplyorde

Exemptions

There is no fee to file an application for an exemption!

What Does An Exemption Do? A homestead exemption removes all or a portion of value from your residence homestead as authorized by the Tax Code or adopted by a local taxing unit and reduces the amount of taxes you pay. It can take up to 90 days for an exemption to reflect on your Tax Office property tax account. We urge taxpayers who believe they are eligible for an exemption to apply to their county appraisal district where the property is located.

Qualifying individuals must submit an application to the appraisal district, not the Tax Office, to receive the homestead exemption. Exemption information, property values, ownership and address updates are handled by the appraisal district in the county where the property is located. Tax Office employees are unable to make changes to your account.

You Can Make a Half Payment on Mineral Accounts

Values are expected to be sent to the Tax Office from Tarrant Appraisal District the last week of November. Bills will be available online the last week of November allowing taxpayers to take advantage of the half payment option.

The Tax Office bills are based on information received from Tarrant Appraisal District (TAD) and nearby appraisal districts in surrounding counties. The appraisal district electronically sends updates to the Tax Office throughout the year. In Tarrant County, the 2025 Mineral Accounts are worked by Capitol Appraisal Group. Important Change for Heavy Equipment Dealers in 2026

Texas House Bill 3424 brings significant changes to filing requirements for Heavy Equipment Dealers beginning in 2026.

New Quarterly Filing Schedule

Starting January 1, 2026, Heavy Equipment Dealers will transition from a monthly to a quarterly reporting and remittance schedule. The Texas Comptroller will introduce a new Quarterly Heavy Equipment Inventory Tax Statement form to support this change.

Dealers must deposit unit property taxes collected on sales, leases, or rentals by the **20th day of the month** following each calendar quarter.

October – December 2026	January 20, 2027

New Recordkeeping Requirement for Heavy Equipment Dealers – HB 3424

Effective January 1, 2026, Texas House Bill 3424 introduces a mandatory recordkeeping requirement for Heavy Equipment Dealers. Under this new legislation, dealers must retain documentation related to all sales, leases, and rentals for a minimum of four years.

The bill removes an older requirement that dealers file duplicate statements with Appraisal District's Office.

HELPFUL PROPERTY TAX TIPS

Attention Dealers: Don't Miss the Deadline: Yearly Tax Declarations Due Soon

Due Date: February 1 of every year

Required forms:

Motor Vehicle Inventory – Form 50-244 Vessels Inventory – Form 50-259 Heavy Equipment Inventory – Form 50-265 Manufactured Housing Inventory – Form 50-267

These forms report the number of units sold over the previous 12-month period (January–December) for the prior tax year.

Important Tip:

Even if no sales occurred, you must still file a declaration showing zero units sold.

DEALER SPECIAL INVENTORY TAX REMINDERS

Dealer's Special Inventory Annual Tax Cycle

December

Annual Inventory & Tax Rate Letters Mailed: Tax Office mails letter with Unit Property Tax factor to use for the upcoming calendar year. Dealers will use these rates starting in February (to report January sales).

January

Escrow Transfer to Pay Property Taxes: December Monthly Statements for the prior year are processed. The Tax Office transfers escrowed funds to pay property taxes.

Deficiency Notices Mailed (if applicable): If the escrowed funds do not cover the total balance due, a Deficiency Notice is mailed to the dealer, reflecting the remaining balance.

Property Taxes are due: January 31, 2026 deadline to pay current taxes without penalty and interest.

February

Declaration must be filed by February 1, 2026: Dealers submit Annual Declarations to both the tax office and to the Tarrant Appraisal District (TAD). TAD assigns value for the current year based on the declaration reflecting prior year sales.

Current year monthly reporting begins: Motor Vehicle, Vessels, and Manufactured Housing dealers begin submitting monthly statements and paying (if applicable) the Special Inventory Tax into an escrow account, using the rates received in December. Heavy Equipment Dealers will start filing quarterly in 2026.

August-September

Values Received from Tarrant Appraisal District: Tax Office receives certified values for the current year from the Tarrant Appraisal District. These values are used to prepare the annual Property Tax Statement.

October

Annual Property Tax Statements Mailed: Dealers receive annual tax statements showing the total taxes due with an important message. *Important Note: Statement includes "Do Not Pay from this statement." The escrow will be applied against taxes due and deficiency notice will be mailed if balance is due.*

How the Tarrant County Tax Office Supports Veterans

At the Tarrant County Tax Office, we are proud to serve those who have served. Veterans and their families can access several important services through our office, including:

Disabled Veteran License Plates

Veterans with a service-connected disability rating of 50% or more (or 40% due to amputation of a lower extremity) are eligible to apply for Disabled Veteran license plates for their car, light truck, or motorcycle. The first set of plates costs only \$3 annually and is exempt from regular registration fees. Additional sets are available with standard registration fees. Veterans may also request the International Symbol of Access (ISA) on their plates if eligible (with a certified doctor's prescription). Apply in person at your local Tarrant County Tax Office

- Required documents: VA disability rating letter and discharge papers (DD-214)

Property Tax Exemptions for Disabled Veterans

Veterans with a service-connected disability rating of 10% or more may qualify for partial or full property tax exemptions on their primary residence.

The exemption amount depends on the disability rating.100% disabled veterans may receive a full exemption from property taxes. Surviving spouses and minor children may also qualify under certain conditions.

Contact the Tarrant Appraisal District at 817-284-0024 to apply. The VA disability rating letter and discharge document (DD-214) may be required.
