## INSTALLATION/REPLACEMENT OF CELL TOWER PERMIT APPLICATION

### REQUIRED DOCUMENTS

Submission must include a plat or map with the proposed location of the communication facility in relation to the residential subdivision sealed by a Registered Professional Land Surveyor.

***The Plat or Map Must Include:***

- a radius of 300 feet from the base of the center of the proposed structure extending to the boundary of the subdivision;
- the Maximum height of the structure; and
- the State Plane North American Datum (NAD 83 x,y coordinates) of the center of the structure.

Submission must include all necessary FCC and/or FAA permits.
