REQUIREMENTS FOR U.S. PASSPORT

- Evidence of U.S. citizenship
  - U.S. Passport Book or Card, Naturalization Certificate, Certificate of Citizenship, Certified Birth Certificate-*long form preferred*, Consular Report of Birth Abroad (photocopies not accepted)
  - Birth certificates **must** have a raised, embossed, or multi-colored seal from the city, county, or state of birth, have both parents listed and must have a file date showing that it was filed within one year of the birth. Proof of citizenship must accompany the application sent to the Department of State; however, it will be returned to you after processing.

**NOTE: Texas** long form birth certificates must list hospital in which applicant was born while Texas abstract birth certificate will need to display a capital letter (I) by the file date. **California** birth certificates must be long form only with hospital listed.  
**(HOSPITAL BIRTH CERTIFICATES ARE NOT ACCEPTABLE FORMS OF CITIZENSHIP)**

- Valid government issued identification with photocopy (front and back)
  - driver license, state issued I.D., military I.D., passport reflecting current appearance or naturalization certificate
- One passport photo (**PHOTOS ARE AVAILABLE AT THE TARRANT COUNTY CLERK PASSPORT OFFICE**)
- Applicant's Social Security Number
- Applicants 16 and 17 years of age must appear in person with one parent. Applicants 15 years of age and under must appear in person with both parents who are named on the birth certificate. The birth certificate must be submitted to establish parent/child relationship, with or without a previous passport for children 15 years of age and under.
